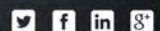

CONSHOHOCKEN BOROUGH AWARDED DEP 902 GRANT FUNDS



On October 16, 2018 the Borough of Conshohocken was notified that it was one out of 195 municipalities to receive 902 grant funds from the Pennsylvania Department of Environmental Protection (DEP). This year the DEP awarded a total of \$37 million dollars to municipalities across the state of Pennsylvania to boost recycling initiative programs. Thanks to the Borough’s Community Development and Zoning Officer, Christine Stetler, Conshohocken was awarded \$212,363 to help improve its leaf and yard waste recycling program. The awarded funds will help purchase a new Swap Loader Truck, which will be customized specifically to address our Borough’s needs.

“By providing these grants, we are helping bolster recycling in communities all over Pennsylvania, and reduce the amount of material going into our landfills,” said DEP Secretary Patrick McDonnell. “Whether it’s from increased education for residents or an entire facility for sorting recyclables, these grants are making a difference.”

The Borough of Conshohocken currently provides a leaf collection program using outdated machinery that requires four (4) employees to operate. Due to equipment restraints and breakdown, leaf collection is sometimes limited to once weekly, and the rotation schedule may not include all streets within the Borough.

The acquisition of this new vehicle will mean a significant improvement to the Borough’s leaf and yard waste recycling program. It will also include a commercial wood chipper, which will eliminate the need to rent equipment for fallen trees debris. Additionally, it can be used for snow plowing, salting and brining streets, clearing out storm water inlets, aiding in potential emergency type situations, and can transport portable containers through the Borough of Conshohocken. Ultimately, this will greatly benefit Conshohocken residents in the following ways:

- **Leaf collection can begin earlier** in the fall and extend throughout the winter months.
- **Leaves can be collected** from all Borough streets and more frequently.
- **An in-house wood chipper will enable timely removal** of tree debris on streets, in parks and trees brought curbside by residents, which will improve both pedestrian and vehicular safety.
- **An in-house wood chipper will decrease recycling costs.** Material from the chipper will increase the Borough’s ability to compost. Wood chips will be added to the compost site, rather than paying the cost of disposal.
- The improvement of composting methods and a larger truck will **decrease the number of trips** made to Upper Merion Township for yard waste disposal and therefore reduce costs.
- The new leaf truck will **only require two (2) employees** to operate the machine as opposed to the four (4) employees it currently requires.
- The reduced number of employees required to operation the leaf collection machine, and the reduced number of trips needed to dispose of yard waste **will allow Public Services to reallocate manpower** to other projects within the Borough. This will help maintain staffing levels and avoid tax increases, which may be needed for personnel and operations.

The Borough is continually looking for ways to improve its recycling program to benefit the residents and future residents of Conshohocken. The new swap loader vehicle was purchased at the end of 2018 and is estimated to be delivered in Fall of 2019, just in time for fall leaf collection.

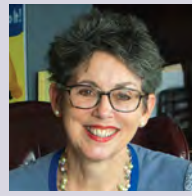

Protect Yourself From Being A Victim of Scams

The police department would like to remind residents of all ages to be mindful of scams. Scams these days come in many forms but all have similar characteristics. The main goal of a scam artist is to obtain your personal information. Your personal information can be used to aid scammers in committing financial fraud crimes such as identity theft, fake check and wire transfers, investment and credit card fraud, and bogus online charitable solicitations. Avoid being a victim of a scam by following this helpful tips:

- **It's shrewd, not rude** to hang up on a suspicious telemarketer.
- **Don't allow unscheduled utility contractors into your home**, even if they have identification.
- **Don't give personal information** to people you don't know unless you initiate the contact.
- **Don't let yourself get pressured** into a verbal agreement or signing a contract.
- **Be skeptical of online offers.** If interested, ask to receive the information in the mail and check to be sure the company is legitimate.
- **Never agree** to pay for products or services in advance.
- **Get estimates and ask for references** on home repair offers and other product services.
- **Contact the Conshohocken Police Department** if you suspect fraud.

COMMUNITY DEVELOPMENT

Fair Housing And Families – Did You Know!

Families are a protected class under the Fair Housing Amendments Act. Protections cover households with children under 18 years of age; pregnant women; and any individual seeking custody of a child under 18.



It is illegal to advertise housing for mature adults only; or no children permitted. Families cannot be segregated to a particular area in a housing complex. Additional fees cannot be charged for families with children; and families cannot be denied housing on the basis that the landlord considers there to be unsafe conditions for children. Rules for the use of amenities available to all tenants cannot completely restrict access by children. Objective criteria and rules for the use of amenities by all residents must be developed.

While it has been determined that the occupancy of bedrooms by 2 individuals, such as a parent and child, is reasonable, the number of people permitted in a unit can be determined by the space available in the unit, and reasonableness related to fair housing is considered on a case by case basis.

Landlords, especially small landlords with a limited number of units, are advised that “no children” policies are illegal. The exception being housing with 4 or less units where the landlord lives in one of the units and does not use the services of a real estate agent.

Families who believe that they have been discriminated against have the right to file complaints with the U. S. Department of Housing and Urban Development, or the Pennsylvania Human Relations Commission. State and/or federal lawsuits also may be filed to resolve discriminatory practices. Landlords are advised that severe penalties may be imposed in either administrative hearings or court suits where practices are found to be discriminatory.

Conshohocken Borough staff can direct individuals wishing to file fair housing complaints to appropriate organizations for assistance.

Housing Rehabilitation Program



The Borough of Conshohocken’s Housing Rehabilitation Program has been in existence for over four decades. During that time the Program has assisted hundreds of Conshohocken homeowners to bring their homes into code conformance in order to enable them to live more comfortably and safely.

Roof repair, window and door replacements, electrical upgrades, sidewalk repair, as well as handicap accessibility, are some of the items the Program can provide to eligible single-family homeowners. The Program now is a four-year Deferred Loan Program, which declines by 25% each year. Program funds are received from the Pennsylvania Department of Housing and Community Development.

New Housing Rehabilitation Income Guidelines

Your income must be below the following limits and includes your salary, pension, Social Security, child support, and interest on assets:

OTHER REQUIREMENTS:

- You must be a Borough of Conshohocken resident.
- You must own and occupy a single-family residence.
- Your taxes and sewer fees must be current.

There are further increases in income limits based on additional family members. The Housing Rehabilitation Program provides one-time assistance only. If the program has provided services in the past, additional work on the same property is not permitted.

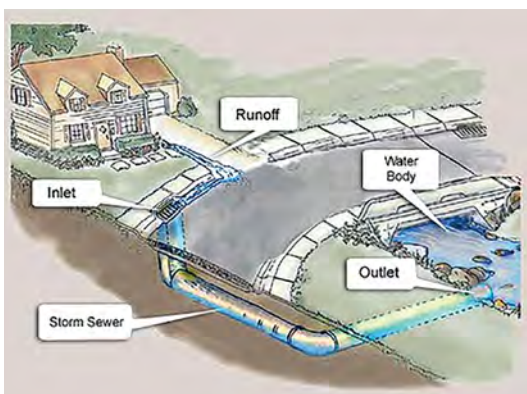

Improve Drinking Water

What can you do on your property and in your community to improve the health of your drinking water?

We can all play an active role in converting our streams, rivers, and surrounding green spaces into healthy systems. As a homeowner, your part can be as simple as maintaining your car properly or placing a rain barrel on your property. This will not only help protect our invaluable drinking water sources but they will help restore our waterways and improve quality of life for all residents. When it rains, anything left on your lawn or the roadway gets carried along in the rainwater, entering the storm sewer system, which carries the water into the local streams and rivers – without treatment!

**The goal is:
“Only Rain
Down Your
Drain!”**



Here are a few ideas on how you can help limit the pollutants reaching the rivers:

MAINTAINING YOUR VEHICLE

- Check regularly for drips and oil leaks and fix them promptly.
- Never dump motor oil, antifreeze, transmission fluid or other engine fluids onto the ground, into the roadway, or down a storm drain.

CARING FOR YOUR LAWN

- Use fertilizers sparingly. Lawns and many plants do not need as much fertilizer or need it as often as you may think. Test your soil first to be sure!
- Let your grass clippings lay! Don't bag the grass. Use a mulching lawn mower to cut one-third of the blade length each week and naturally fertilize your lawn in the process.
- Bag up pet waste and put it in the trash.

PLANTERS AND CONTAINER GARDENS:

Planters retain rainfall rather than allowing it to directly drain into nearby storm sewers and streams and can be placed on impervious surfaces like sidewalks, back yards, rooftops, or along the perimeter of a building in order to catch stormwater runoff from the roof.

RAIN BARRELS:

By temporarily holding the stormwater runoff collected from rooftops during rainfall, the collected rain water can be reused after the storm for irrigation to water lawns and gardens. Rain barrels are only effective at stormwater management when the stored water is emptied in between storms, making room in the barrel for the next storm.

New Roll Cart Trashcans Coming to the Borough

In 2019, the Borough will be distributing 64-gallon trash and recycle carts to each parcel number. Each parcel, including apartment complexes with Borough trash service, will receive one trash cart and one recycle cart at no charge. It is your responsibility to manage and care for your Borough issued carts. In the event you move, your carts should remain at the house for use by the next resident.



PLEASE NOTE: All parcels that are currently utilizing roll cart trashcans may continue to use their existing cart(s). Acceptable carts must include 2 wheels, a metal lift bar, and an attached lid. If you would like to opt out of receiving a trash and/or recycle cart because you are already utilizing one, please contact Public Services at (610) 828-1092. If you have any questions regarding acceptable carts please do not hesitate to contact us.

Specific delivery details will be posted to our website prior to the rollout. Once the initial delivery of the carts is completed, additional carts will be made available for purchase for \$54.00 each. An order form will be posted on our website.

If you should need special accommodations, such as a smaller recycling/ trash can, please contact Allison Flounders at the Borough Administrative Office (610) 828-1092. Note: Borough Administration reserves the right to review and approve requested special accommodations.

Trash Collection Rules and Regulations:

Trash collection rules and regulations will be updated in 2019.

- There is a limit of 4 cans/bags per household per pick-up (200 pounds maximum).
- Each can/bag is not to be heavier than 50 pounds.
- Needles, syringes, lances and other sharp objects should be placed in a metal container with a secure lid so as not to be a hazard.
- Please place your cans/bags at curbside on your property no earlier than 5:00 PM the night before. Your cans must be removed from curbside no later than 7:00 PM the day of collection.
- No clean-outs or move-outs unless prearranged 24 hours in advance. Please call (610) 828-1092.
- No construction debris or carpet unless prearranged 24 hours in advance. Please call (610) 828-1092.
- Trash will be left curbside and 'red tagged' if deemed to be too heavy or improperly placed. Trash that is left should be returned to the property before 7:00 PM.

Yard Waste Collection Rules and Regulations:

All residences must participate in the Borough's recycling programs by separating their recyclable material from their regular trash. Yard waste is recyclable, therefore the separation and collection of this material is mandated by the Commonwealth of Pennsylvania and Conshohocken Borough.

- Weeds, leaves, brush and plants should be placed in biodegradable paper composting bags. Please no trash in these bags.
- Each bag should not be heavier than 50 pounds.
- Tree branches under five (5") in diameter, not exceeding five (5') in length, are to be securely tied into bundles and should not be heavier than 50 pounds.
- Christmas trees. Please no decorations, tree stands or plastic tree bags.
- Please place your bags and/or bundles at curbside on your property no earlier than 5:00 PM the night before.
- There is no limit of yard waste collected that is determined to be reasonable by the Borough.

Snow Removal

You may notice the Public Services crew pre-treating the roads with our new liquid brine machine before snowstorms. The brine solution is created at the Public Services garage. To create it, a mixture of salt and water is put into a large tank where it is mixed together to form 23% salinity. Then, it is pumped into a large holding tank until being transferred to one of the two designated Public Services trucks with 300-gallon storage tanks on the back of them. When sprayed on the roads the brine works by settling into tiny crevices on roadways, creating a layer that prevents the ice and snow from bonding with the pavement. If you notice that the brine machine is NOT being used it is because it is only effective when used during certain types of ice and/or snowstorms.

When it snows it's Public Services' goal to have all Borough and state roads cleared within six to 10 hours after the snow has stopped falling. Please refrain from parking on the street if you have off street parking. This will help our crews do a better job. Residents should clear their sidewalks after plowing has been completed. A three-foot-wide path of sidewalk must be cleared on your property within 24 hours after the snow has stopped. Don't forget your crosswalks, handicapped ramps, and alley crossings! The Borough does not plow snow in alleys.

It is illegal to shovel, throw or plow snow from sidewalks onto street parking, or driveways and allies into the street or right-of way. Dumping snow or ice on Borough property, or plowing snow across a street is also prohibited. Remember to remove your vehicle from any posted "Snow Emergency Route" when the Mayor has declared a snow emergency. Vehicles must be removed until after the parking lanes have been completely cleared.

Licenses & Inspections

Licenses & Inspections personnel work diligently to preserve and protect the health, safety and welfare of the public throughout all facets of property ownership, residency, development, construction and business operation within Conshohocken Borough.

Frequently Asked Questions . . .

Do I need a permit for...? Any work beyond a basic repair or a non-structural alteration may require a building permit issued by the Borough's Building Code Official for both residential and commercial properties. The best course of action is to contact the Borough at (610) 828-1092, and ask a building inspector if a permit is required for your project. Be prepared to provide a detailed scope of work for the project, and identify the property as residential or commercial. Change in use may require zoning approval.

Am I responsible for maintaining the alley behind my house? Yes. Typically, the property owners on each side of an alley are responsible to maintain to the center of the alley for the width of each respective property. This includes the alley pavement surface (e.g. potholes), as well as grass, weeds, trash, etc., that may be found in an alley, regardless of how it ended up there. Weeds on the other side of your fence along the alley are still part of your property, and therefore your responsibility to trim and/or spray. The Borough does not plow snow in alleys.

Why does the Borough need to inspect the home I'm selling? Borough Ordinance Chapter 11, Part 1 governs Transfer of Real Estate and Real Estate Certification. Per §11-111, anyone selling a property in the Borough is responsible to certify that there are no uncorrected violations of any housing, building, zoning, and safety or fire codes. The Borough performs an inspection based on a Real Estate Certification Checklist, which was adopted by Borough Council and records any apparent violations. It is required that all violations be corrected prior to settlement, or the responsibility to correct said violations may be transferred to the buyer, who will have 12 months to complete the work. The terms of such a transfer are private and fall outside of the Borough's authority.

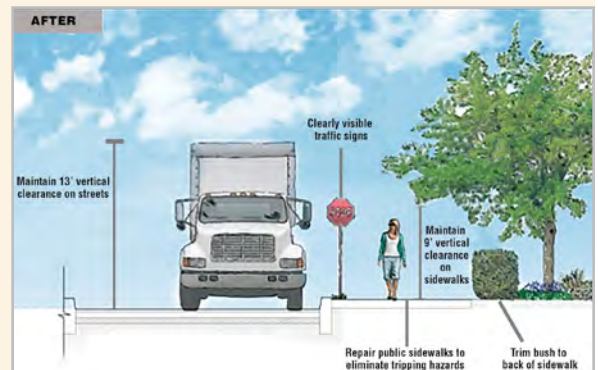
Where exactly is my property line? Absent physically apparent monuments or property corner pins, the Borough cannot independently verify property lines on behalf of private property owners. Property owners are encouraged to engage a Professional Land Surveyor to prepare a site plan and physically set corner markers. This information is useful for locating potential property improvements such as fences and garages, laying out additions to the primary structure, and to satisfy property line disputes, if necessary. Plans for newer homes may be available at the Borough office. File a Right-to-Know Request, and the Borough staff will search the archives.

How do I register a new rental property? Borough Ordinance Chapter 11, Part 2 governs Residential Rental License Permits. Visit the Borough website and download the Rental Packet for New Rentals from the "Forms" list under the Permits & Licenses section.

Property Maintenance & Safety

As a property owner, you are responsible for mowing, trimming and spraying, as necessary to keep your property, as well as the public street frontage, clean and safe. The illustration at right highlights some of the requirements for private maintenance of public-right-of-ways.

SUMMER BACKYARD SAFETY TIPS

- **Keep grills at least 10 feet from any structure:** Grilling mishaps cause more than 8,300 fires and send 3,000 people to the emergency room each year. Never grill indoors or near garages or porches, even if it's raining.
- **Have a spray bottle or fire extinguisher handy:** An unexpected flare up can burn more than your burgers. Use a spray bottle to avoid flare ups and have a fire extinguisher nearby. Also, coals get hot – in some cases up to 1,000 degrees Fahrenheit – so dispose of charcoal away from kids and pets and cool it down with a hose.
- **Never use gasoline or kerosene to light a charcoal fire:** Both can cause an explosion. When grilling, use insulated, flame-retardant mitts and long-handled barbecue tongs and utensils to handle food and coals.
- **Check gas grill hoses for cracking, brittleness, holes and leaks:** If the tank valve or grill needs repair, do not attempt to do it yourself. Take it to your local home improvement store or qualified appliance repair person.
- **Inspect outdoor decorative lights carefully:** Some families add backyard ambiance with outdoor decorative lighting. Do not connect more than three midjet light string sets together. Light strings with screw-in bulbs should have a maximum of 50 bulbs connected together. Be sure to use light strings bearing the UL Mark, which means UL has tested samples of the product for risk of fire, electric shock and other hazards.

Fourth of July Safety Tips

As Fourth of July celebrations approach, residents are reminded to use caution when interacting with fireworks. Fireworks, and/or sparklers can cause fires, burns, dismemberment or death if handled improperly. Pennsylvania residents are permitted to purchase and use consumer grade fireworks that contain a maximum of 50 milligrams of explosive material. M-80's, cherry bombs, quarter sticks and any other explosive or incendiary devices with more than 50 milligrams of explosive materials and are strictly prohibited. Furthermore, the use and discharge of all display fireworks, including sparklers, is prohibited on all Borough property and parks.

USE AND RESTRICTIONS

- Fireworks cannot be ignited or discharged on a public or private property without express permission of the property owner.
- Fireworks cannot be discharged from or within a motor vehicle or building.
- Fireworks cannot be discharged toward a motor vehicle or building.
- Fireworks cannot be discharged within 150 feet of an occupied structure.
- Fireworks cannot be discharged while the person is under the influence of alcohol, a controlled substance, or another drug.

Ultimately, handling fireworks should be left to the professionals! Restrictions on fireworks are for a good cause. No matter how small or large fireworks may be, they are a potential fire starter. It is still possible to celebrate and enjoy the holiday. Families can consult the newspaper or local activity calendar and attend one of several approved, licensed fireworks displays.

THE SPOTTED LANTERNFLY

A Spotted Lanternfly (SLF) quarantine is currently in effect for 13 counties in Pennsylvania, including Montgomery, Chester, Bucks, and Delaware Counties. The Spotted Lanternfly (*Lycorma delicatula*) is an invasive plant hopper, native to Asia that was first detected in 2014 in southeastern Pennsylvania. This insect has the potential to greatly impact fruit trees, hops, and logging industries. Early detection is vital for the protection of Pennsylvania businesses and agriculture.



QUICK FACTS

- SLF is a destructive invasive pest, threatening agricultural, timber, and ornamental industries, and plants in your backyard.
- SLF is currently under quarantine in 13 counties in Pennsylvania including Montgomery County.
- SLF does not bite or sting.
- There is one generation of SLF per year. The eggs are laid in the fall and hatch in the spring. Egg masses are laid on hard surfaces (trees, decks, houses, outdoor equipment, rocks, etc.) and protected with a mud-like covering.
- Stop the spread of SLF by checking your car and any outdoor equipment (grills, mowers, firewood, etc.) when going in and out of the quarantine zone.
- Manage SLF on your property by scraping eggs, banding trees, removing the favored host (tree-of-heaven), and using chemical control when appropriate. For more information visit: extension.psu.edu/spotted-lanternfly.

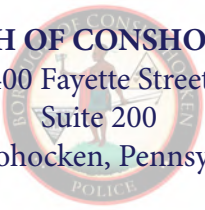
