

**BOROUGH OF CONSHOHOCKEN
WORK SESSION
NOVEMBER 7, 2007**

Members of Council present at the Work Session Meeting were Mr. Jack Coll, Mr. James Griffin, Mr. Robert Stokley, Mr. Vincent Totaro, Mr. Peter Cianci and Ms. Deborah Stovall.

A parking waiver hearing was held for 103-105 Fayette Street and 525 Fayette Street. There was discussion on 103-105 Fayette Street in reference to cars stopping on Fayette Street to pick up pretzels. The owner of the property assured Council signs will be posted along the front of the curb of the store.

A motion by Mr. Totaro to approve the parking waiver request for 103-105 Fayette Street. Seconded by Mr. Cianci. All voted in favor. Motion passed.

A motion by Mr. Totaro to approve the parking waiver request for 525 Fayette Street. Seconded by Mr. Coll. All voted in favor. Motion passed.

Mrs. Caterbone informed the public that interviews were held for the position of Mayor. It was a difficult decision for Council but they all agreed to appoint Joseph Collins.

A motion by Mr. Coll to appoint Joseph Collins as Mayor. Seconded by Mr. Cianci. A Roll Call was taken. Mr. Coll, Mr. Griffin, Mr. Stokley, Mr. Totaro, Mr. Cianci, and Ms. Stovall voted in favor. Motion passed by 6-0 vote.

Mr. Collins was sworn in by Council President.

Mr. Collins thanked Council for the appointment as Mayor; he will do his best to uphold the office.

A motion by Mr. Stokley to approve the change order for the 2007 Road Program in the adjusted contract amount of \$316,640.03, the extra work cost is \$44,449.52. Seconded by Mr. Coll. All voted in favor. Motion passed.

Interviews were held for the Public Works Department.

A motion by Mr. Stokley to hire Harry Silverwood as an employee of the Public Works Department effective November 27, 2007. Seconded by Mr. Cianci. All voted in favor. Motion passed.

A motion by Mr. Stokley to hire Martin Brown as an employee of the Public Works Department effective November 26, 2007. Seconded by Mr. Cianci. All voted in favor. Motion passed.

All other applicants will be kept on file.

A motion by Mr. Coll to authorize Remington Vernick & Beach to prepare Streetscape improvements for the 400 block of Fayette Street. Seconded by Mr. Stokley. All voted in favor. Motion passed.

A motion by Mr. Stokley to approve a handicapped parking space at 425 West 11th Avenue. Seconded by Mr. Coll. All voted in favor. Motion passed.

A motion by Mr. Stokley to approve a waiver of Land Development for 450 Colwell Lane subject to submission of a fully engineered Storm Water Management plan and any other engineered plans deemed necessary by Borough Engineer and subject to applicant posting an escrow sufficient to secure payment of all engineering review fees. Seconded by Mr. Coll. All voted in favor. Motion passed.
