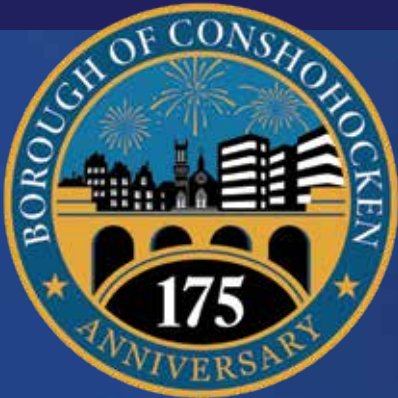

175 YEARS OF THE BOROUGH OF CONSHOHOCKEN

It's been a year to celebrate so far in the Borough of Conshohocken!

This year marks the Borough's 175th anniversary of its incorporation, which took place on May 15, 1850, allowing Conshohocken to become the third Borough in Montgomery County after Norristown (1812) and Pottstown (1815).

The Borough of Conshohocken recognized this milestone during the month of May.



On May 10, the Borough hosted the Simon's Heart Conshy Classic and 175th Anniversary Celebration.

In its second year, the Conshy Classic—which benefits Simon's Heart and Johnnie's Place—brought

over 270 of the region's best amateur and professional cyclists to compete on a challenging course comprised of the Borough's lower end. In addition to the Conshy Classic, the Borough and local bars and restaurants turned Fayette Street into a party with food and great music from The Wonton Soup, Don't Call Me Francis, and Modern Luxe.

The festivities continued that night on Washington Street with the 175th Anniversary Celebration. This event featured family-friendly activities, including inflatable obstacle courses and games from Beanie Bounce, a bubble party provided by Bucks Bubbles, and face painting and glitter tattoos by Fabulous Faces.



The highlight was a drone show over the Schuylkill River by StarFlight Drones Shows!

The Borough wasn't the only one that acknowledged its 175 years of incorporation!

During the May 21 Borough Council meeting, Thomas Weikel, President of the Pennsylvania State Association of

Boroughs (PSAB), attended and acknowledged the Borough for its 175th anniversary. Borough Council members, past and present, were on hand for this recognition by the PSAB.

In addition to these wonderful events in May, the Borough put the "Play" in "Live, Work, Play, Grow" throughout the first half of the Borough's 175th year with the annual Montgomery County St. Patrick's Day Parade in March, the Conshohocken Arts Festival and Car Show and the Philadelphia Flyers Alumni Association Walk, Run, Ride in June, and the annual July 3rd Fireworks Display and Soap Box Derby in July.



We will continue to celebrate our 175th anniversary during the rest of 2025 with Funfest on September 20, our annual Halloween Parade on October 18, and the Christmas Tree Lighting hosted by AMBUCS on November 28.

ENVIRONMENTAL ADVISORY COUNCIL

Help keep Conshy clean! If you care about environmental issues and their impact on our community, come meet the Conshohocken Environmental Advisory Council. Meetings are held on the third Thursday of each month, and we discuss the current Borough and community-led initiatives to make our area more "green" and sustainable.

Join us for one of our semi-annual Community Clean Ups, where residents, as well as school, church, and community groups, come together to remove trash from our sidewalks, streets, and storm drains.

These events are also a great opportunity for local organizations and businesses to get involved with the community. Clean-ups are held each Fall and Spring, and volunteers are provided bags, gloves, and snacks. To further promote our clean streets initiative, the Borough purchased a street sweeper. If you see one of our friendly Public Services employees driving it along our streets, give it a wave!

To educate the community on environmentally friendly practices they can implement at home, the EAC hosts the annual Conshy Greenfest with booths hosted by local nonprofits and companies. Our 2025 Greenfest featured businesses like PosiGen Home Solar, a local business focusing on affordable solar panels for all, student booths from Plymouth-Whitemarsh's International Baccalaureate program, which showcased kids' upcycling arts and crafts ideas, and community groups like the Conshohocken Community Garden, which gave away seeds and plants for home gardens. Larger companies, including IKEA and REI Co-op, which have a local presence, also hosted booths that showcased their focus on sustainable practices and environmentally friendly products.

ZONING SERVICES

The rules for each zoning district are outlined in the Borough's Zoning Ordinance, which determines the specific land uses that are permitted in each district, such as residential, office, commercial, or industrial. The code also outlines the dimensional standards for each district, such as maximum building and impervious coverage, minimum building setbacks, and maximum building heights.

Zoning Permits:

The Zoning Ordinance includes regulations governing off-street parking, patios, walkways, signs, fences, and accessory structures. Zoning permits are required for these.

The application for a Zoning Permit can be found on the Borough's website, www.conshohockenpa.gov. The permit fee is a flat fee of \$50.00, and permits require two weeks to process for completed applications.

Zoning Hearing Board Applications:

The Zoning Hearing Board conducts public hearings at the request of developers and residents seeking zoning relief from a provision of the Zoning Ordinance via variance or special exception. The Board meets when an application and/or zoning petition has been submitted with all applicable documentation and fees. The Zoning Hearing Board reviews applications on a case-by-case basis and makes determinations based on the Borough's Zoning Ordinance.

Meeting dates, changes, and/or cancellations are posted on the Borough's website.

Paul Miller's Law

FIRE SERVICES

The Fire Services Team works closely with Licensing & Inspections, Emergency Management, the Police Department, and Narberth Ambulance to further ensure the protection of life and property of our citizens, visitors, and businesses.

The Borough of Conshohocken employs three full-time career firefighters, who also serve as the Borough's fire inspectors, along with part-time firefighters. Fire inspectors perform annual inspections on fire alarms and fire protection systems in new and/or existing commercial buildings within the Borough of Conshohocken.

State and local fire codes require that every business undergo regular fire inspections. Fire Services for Conshohocken also consists of two volunteer fire stations--Washington Fire Company No. 1 and Conshohocken Fire Company No. 2. Both fire companies operate under Station 55 and provide volunteer firefighting services to the Borough of Conshohocken.

Home & Fire Safety

The Conshohocken Fire Department has noticed an increase in electrical house fires due to the misuse of power strips. It is important to use power strips correctly. Never use multiple extension cords in one outlet. Overloading outlets, circuits, and extension cords by plugging too many things into one area can cause an electrical fire.

Avoid potential fires by following these safety tips:

- Check to ensure that all electrical cords are in good condition and are not broken or cut.
- Clean the lint from your dryer after every use.
- Check to ensure that all plug outlets are safe and do not feel warm when you touch them. If they are warm, call an electrician.

Free Smoke Detectors & Installation

Free smoke detectors are available to property owners at Borough Hall (400 Fayette Street, Suite 200, Conshohocken, PA 19428). Supplies are limited to three (3) smoke detectors per household.

Residents requiring special accommodations may arrange to have their smoke detectors delivered and/or installed at no charge. Please

contact the Fire Chief directly to arrange.

Carbon Monoxide Alarms

- Install carbon monoxide alarms on each level of your home.
- Make sure carbon monoxide alarms are less than 7 years old.

Fire Hydrant Clearance

Ensure firefighters have access to fire hydrants at any time of the year. Wintry weather can create fire safety hazards, such as ice or heavy snowfall that can obstruct fire hydrants. You can help reduce the risk by keeping fire hydrants accessible and clear of ice and snow.

Fire Prevention Education & Events

Fire Services offers a variety of educational opportunities and events to raise awareness about fire safety. Conshohocken's Fire Services Team provides on-site fire safety education year-round to the community at no cost.

We encourage schools and businesses within the Borough of Conshohocken to contact the Fire Chief to learn more or to schedule an on-site visit today!

The Borough of Conshohocken is hosting the Colonial Fire Expo on Wednesday, October 8 on Fayette Street between 3rd and 6th Avenues from 5 to 9 p.m. The Colonial Fire Expo is an annual event that features the fire departments from Conshohocken, Plymouth Township, and Whitmarsh Township. The night is full of fun, interactive and educational displays, including vehicle, water, and high-angle rescue demonstrations.

10 Things You Can Do to Prevent Stormwater Runoff Pollution

1. Use fertilizers sparingly and avoid pesticides
2. Sweep up driveways, sidewalks, and roads
3. Never dump anything down storm drains
4. Vegetate bare spots in your yard
5. Compost your yard waste
6. Direct downspouts away from paved surfaces
7. Check your car for leaks and recycle motor oil
8. Clean up after your pet
9. Use a car wash instead of washing your car in the driveway
10. Reduce salt use in the winter

Steps to be Salt Smart

No salt product is completely harm-free, so the best way to help the environment is with your application:

- Shovel first. Clear snow from driveways and sidewalks before it turns to ice.
- More salt does not mean more melting. A 12-ounce coffee mug of salt should be enough for 500 square feet of driveway or about 10 sidewalk squares.
- Distribute salt evenly, not in clumps.

Thank you for doing your part to keep your neighborhood safe and protect our rivers.

If you notice water flowing in the public storm sewer system during times of dry weather, this is a potential sign that there could be a problem. Please report any concerns to Conshohocken Borough at 610-828-1092.

Trash & Recycling Cart Updates

Borough-approved containers must be used for all residential trash and recycling unless other arrangements have been made and approved by the Public Services Department. Trash and recycling cans must have 2 wheels, a metal lift bar, and attached lid. Unapproved containers will be tagged for no future pickups until the residence comes into compliance.



Trash Collection Rules and Regulations

- There is a limit of four (4) cans/bags per household per pick-up (200 pounds maximum)
- Each can/bag is not to be heavier than 50 pounds.
- Needles, syringes, lances, and other sharp objects should be placed in a metal container with a secure lid so as not to be a hazard.
- Each household is permitted to dispose of one (1) large piece of furniture or bulk item per month with regular trash. This includes sofas, box springs, plastic siding, TVs and all electronics. All other bulk trash or bulk metal collection must be arranged through the Borough of Conshohocken by calling 610-828-1092.
- Please place your cans/bags at curbside on your property no earlier than 5 p.m. the night before and your cans must be removed from curbside no later than 7 p.m. the day of collection.
- No construction debris, carpet, clean-outs, or move-outs unless approved by the Licenses and Inspections Department. Please call 610-828-1092.

Conshohocken Is Single Stream Recycling

Single stream recycling allows all your recyclable materials to be placed into one recycling container. The best part is you do not have to separate them! Hence, we get the term '*Single Stream Recycling*.' Residents will see trash trucks collecting recyclables. Rest assured recycled materials will go to the recycling facility, NOT the trash-to-steam plant. Recycling carts should be left out before 7 a.m. on collection day, at the front edge of your property or nominated collection point.

Yard Waste Collection Rules and Regulations

Yard waste stickers are available at the Borough office to convert your old blue recycle bin into a container for yard waste disposal.

All residents must participate in the Borough's recycling programs by separating their recyclable material from their regular trash. Yard waste is recyclable; therefore, the separation and collection of this material is mandated by the Commonwealth of Pennsylvania and Conshohocken Borough.

- Weeds, leaves, brush, and plants should be placed in biodegradable paper composting bags. Please, no trash in these bags.
- Each bag should not be heavier than 50 pounds.
- Tree branches under five (5") in diameter, not exceeding five (5') in length, are to be securely tied into bundles and should not be heavier than 50 pounds.
- Christmas trees. No decorations, tree stands or plastic tree bags.
- Please place your bags, and/or bundles at curbside on your property no earlier than 5:00 PM the night before.

PUBLIC SERVICES CONTINUED

Christmas Tree Recycling

Public Works collects Christmas trees each year following the holiday. Christmas trees should be placed curbside the Tuesday before yard waste collection. The trees are collected, chipped, and composted. All tree bags, ornaments, lights, and stands must be removed.



Snow Removal

Efficient snow removal helps ensure the safety of our residents, visitors, and those traveling through the Borough. When it snows, Public Services makes every effort to clear all Borough and state roads within six (6) to 10 hours after snow has stopped falling. Public Services utilizes a snow management plan that consists of pre-treating roads with a brine solution and plowing during and after a snowstorm. Please refrain from parking on the street if you have off-street parking available.

Plowing

Residents with off street parking should refrain from parking on the street so that Public Services can clear more of the road. Cones, lawn chairs or other objects used to reserve parking spaces during a snowstorm are prohibited. Public Services will not stop plowing to remove objects used to reserve parking spaces.

State and Local Roads

Public Services is responsible for plowing all local and state (PennDOT) owned roads, including the Matsonford Bridge and train station cross walks within the Borough of Conshohocken. SEPTA is responsible for clearing snow from the train station and all steps and/or staircases accessing the train station.

Declared Snow Emergency

When the Mayor declares a snow emergency, residents are required to remove their vehicles from any of the Snow Emergency Routes designated below. During a declared snow emergency parking is restricted in these areas and vehicles may be towed.

Snow Emergency Routes

- Fayette Street, both sides from the Conshohocken Borough line to the bridge.
- The south side of Freedley Street from 12th to 11th Avenues.
- Poplar Street from Elm Street to Washington Street.
- East First Ave. (Harry Street to Fayette Street)
- West First Ave. (Fayette Street to Forrest Street)

Snow Removal Reminders for Residents

- Residents should clear their sidewalks after plowing has been completed.
- *It is illegal to shovel, throw or plow snow from sidewalks onto street parking, driveways, allies and into the street or right-of-way.*
- Please use caution while shoveling heavy, deep snow from your property.
- A 3-foot-wide path on the sidewalk must be cleared on your property within 24 hours after the snow has stopped. Don't forget your crosswalks, handicapped ramps, and alley crossing. The Borough does not plow snow in alleys.
- Dumping snow or ice on Borough property or plowing snow across a street is also prohibited.

EMERGENCY MANAGEMENT

The Department of Emergency Management has been undergoing continued training with the County, State, and Federal Emergency Management teams to ensure preparedness for your safety in all incidents and events. This past year, this training included attendance at the Emergency Disaster Incident Training Symposium (EDITS), where staff members heard from leaders across the country who have experienced public disaster incidents firsthand. The department, which consists of members from the Police Department, Fire Department, Narberth Ambulance, Borough Administration, and Public Services, will utilize lessons learned in this training to continue updating the Borough's emergency operations plans and standard operating procedures.

Flood Gauge

The Borough of Conshohocken, in partnership with the United States Geological Survey, has added additional equipment to the Schuylkill River Flood Gauge on the Matsonford Bridge to assist in measuring the height and velocity of the river. LICENSES & INSPECTIONS

Through permits, inspection, and enforcement, the Licenses & Inspections Department is responsible for the administration of Borough, State, and Federal Codes and Ordinances that pertain to Building Construction, Zoning, Land Development, Housing, and Property Maintenance.

Licenses & Inspections respond to property maintenance complaints concerning issues such as lawn maintenance and snow removal. They are also responsible for the inspections of building construction, rentals and resale, and property maintenance. Unlike other municipalities in Montgomery County, Conshohocken's Licenses & Inspections Department handles 100% of the required building construction inspections.

Licenses & Inspections works closely with the Police, Fire, and Public Services Departments to ensure the health and safety of the Borough residents.

HOUSING REHABILITATION PROGRAM

Improvements to the homes of low/moderate-income Conshohocken residents are available through Conshohocken's Housing Rehabilitation Program. The Program has been in operation since the early 1980s. It is designed to bring older properties into compliance with the local building code and provide homeowners with safer, more comfortable living.

Work can include roof repair, window and door replacement, electrical, plumbing, kitchen and bathroom improvements, sidewalk repair, and handicap accessibility.

The Program is a four-year deferred loan program, which forgives one-quarter of the loan amount each year. No repayment is required unless the property is sold or leased.

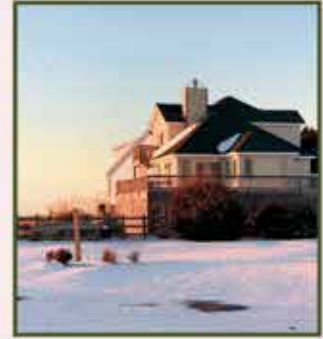

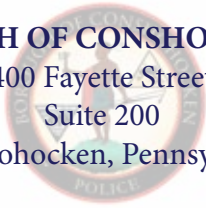
